

DECLARATION OF PARTICIPATION IN A SPORTING EVENT

The participant declares that:

- 1) knowingly and voluntarily submits his/her application for the event, which is organized in cooperation and under the auspices of the Czech Federation of Wushu and Other Martial Arts (hereinafter referred to as "ČFW") and the organizer, who is a member of the ČFW.
- 2) is physically and mentally fit to participate in the event, that his/her health is in good condition, that he/she has not been diagnosed with any serious illness or has been ordered or recommended any health restrictions that would prevent him/her from participating in the event or that would pose an increased risk of injury or other health complications when participating in the event, and that he/she is not aware of any other health problems that would prevent him/her from participating in the event or that would pose an increased risk of injury or other health complications when participating in the event,
- 3) will comply with the safety and organizational rules communicated to him by the organizer throughout the duration of the event, that he will follow all instructions and guidelines and that he will act during the event in such a way as not to cause any harm to himself or other participants in the event,
- 4) will behave professionally and courteously throughout the event, and that he/she will be subject to any sanctions for violations related to this; the participant acknowledges that the protest must be conducted in accordance with the rules of the event, addressed to the main referee of the platform,
- 5) by signing this declaration, he/she has provided the ČFW with true and complete information about his/her health status and physical condition,
- 6) did not conceal from the ČFW any facts, that could endanger his safety or the safety of other participants in the event,
- 7) understands the health risks associated with participating in the event and participates in the event solely at their own risk and responsibility,
- 8) is aware of all the consequences associated with his/her participation in the event at his/her own risk and responsibility, in particular the fact that ČFW and the organizer are not liable for any injuries, damage, or death, personal injury to the participant and other property or non-property damage, which may occur as a result of participation in this event or due to the negligence of another participant, including the party exempted from liability, whether passively or actively,
- 9) assumes all risks related to any damage, injury or harm that the participant may suffer as a result of his registration for the event and his participation, including all risks related thereto, whether foreseeable or not,
- 10) fully understands that all medical care or treatment that will be provided to the participant in the event in case of an injury is of the nature of first aid, and that the

ČFW, the organizer, their representatives, volunteers and other members of the event do not assume responsibility for such assistance; the participant is aware that in the event of an injury it is necessary for the participant to secure proper medical treatment himself,

- 11)** understands, that it is his/her own responsibility to secure health insurance, that will cover any possible injuries, accidents, illnesses or other harm, that the participant may suffer during participation in the event, and that the ČFW or the organizer do not provide any such health insurance,
- 12)** it is his intention through this statement to release ČFW, the event organizer and their representatives from liability for personal injury, property damage, death, regardless of the cause, including, but not limited to, the negligence of the released party, whether passively or actively.

The participant further declares that:

- 1)** is aware of and agrees that his/her appearance, competition performance and participation in the event may be filmed or otherwise recorded, published and broadcast live streamed,
- 2)** he agree that ČFW and the event organizer may use his name, address, partial or complete image or sound recordings and other data, in any form and language, without limitation, for television, radio, video or other media, through any devices

By signing, the participant confirms that he/she has fully informed himself/herself about the content of this declaration by reading it before signing it. By signing, the participant also confirms that he/she has become familiar with the rules and regulations of the event and is aware that these rules and regulations of the event are also intended to ensure the safety and protection of the participants of the event.

If the participant has not reached the age of 18, this declaration is signed by the participant's legal representative (parent). In the event that any provision of this Statement is for any reason declared by a court of competent jurisdiction to be invalid or unenforceable in any respect, such illegality, invalidity or unenforceability shall not affect the remaining provisions of this Statement and this Statement shall be construed as if it never contained such illegal, invalid or unenforceable provision.
